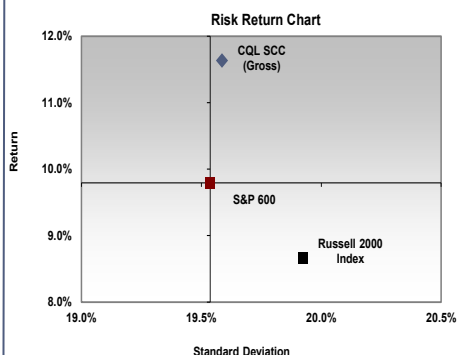

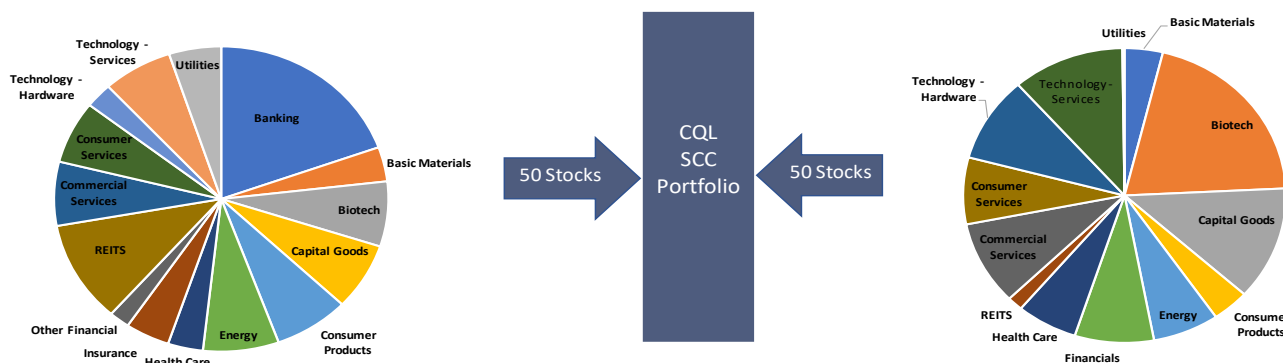

Firm Information: The firm's fee schedule for Small Cap Core is as follows: 0.50% for the first \$50 million, 0.45% on the remainder.

Composite Characteristics: The CQL Small Cap Core Equity Composite was created in February 2021. The composite includes all Small Cap Core style specific portfolios. A complete list and description of all firm composites is available upon request. The composite benchmark is the Russell 2000 Index which is a Small Cap Core index.

Calculation Method: Valuations and returns are computed and stated in U.S. dollars, and individual portfolios are revalued daily. Returns are calculated both net and gross of management fees, net of transaction costs, and gross of custodial fees. Net of fee returns are calculated by reducing the composite's gross return by the maximum applicable fee. The composite results portrayed reflect the reinvestment of dividends, capital gains, and other earnings when appropriate, including accruals.
